### KID IS A VALUED PARTNER TO HEALTH AND SAFETY ORGANIZATIONS IN CHICAGO AND AROUND THE COUNTRY.

Since 2011, KID has attended the **Community Baby Shower at Prentice Hospital** in Chicago. This year KID distributed 500 new mom safety kits at the event. Jill Stein, Resource Coordinator at Northwestern Medical Group, had the following to say about the event and why KID's presence is necessary.

#### How did you get connected to KID?

My mother in law was actually a colleague of Linda and Boaz (KID founders) for some time and my own daughter was born just days after their son Danny's death. So from the onset of being a parent, I knew how important and how real the issue of product safety was. Sadly, it is an often overlooked or ignored topic for parents and caregivers.

That's why when I took over the biannual Community Baby Shower at Prentice three years ago, I was thrilled to see KID already a part of the event. I have tried to make the baby shower a one-stop shop for parents where they can go see all the resources and support available to them. **KID is definitely one of those vital resources.**

# Why is it important for KID to be at these community outreach events?

In my opinion, KID brings awareness to a topic that parents and caregivers might otherwise overlook. There is just such a learning curve for new parents; so much information to know and not nearly the time to know it all. KID's presence at community events like the Prentice Baby Shower help bridge that gap.

#### What is KID bringing to the table?

Without KID, parents wouldn't have easy access to this information. What's more, they wouldn't even know they needed this information and as a result, they would never get it. KID helps to bring important attention to this often over- looked, but very real issue.

### KID RESEARCH CONTINUES TO DRIVE NATIONAL DISCUSSION ON RECALL EFFECTIVENESS.

Media, regulators, advocates and industry look to the KID annual report on children's product recalls for important data on hazards, recall effectiveness and safety.


A Decade of Data: An In-depth Look at 2014 and a Ten-Year Retrospective on Children's Product Recalls reviewed recall data from the US Consumer Product Safety Commission (CPSC) for 2014 and the prior nine years.

The report found that incidents, injuries, the recalls and the deaths related to them have decreased. A review of trends over the past decade show that new mandatory standards required by the 2008 Consumer Product Safety Improvement Act (CPSIA) and "Danny's Law" reduced deaths and recalls of the regulated products. There was however only small progress toward getting recalled products out of homes. Eighty percent of recalled products are unaccounted for - many still in use.

Stronger standards, port surveillance and testing requirements have reduced recalls and improved safety. We need to keep strengthening that safety net and address the gap between recalling a product and getting it out of our homes.

The report was widely covered by media and referenced often throughout the year in discussions on improving recall effectiveness.

Building strong coalitions allows our small organization to tackle big issues. From broad national coalitions focusing on CPSC oversight and congressional action to a strong statewide coalition in Illinois working on safe sleep, KID engages partners in our work.

# SAFE SLEEP

Bumper pads are involved in dozens of deaths and contribute greatly to confusion over the safe sleep message that **"Bare is Best."** Our coalition, with leadership from **KID**, **Illinois Action for Children**, **SIDS of Illinois**, **Everthrive Illinois** and others, passed legislation in the Illinois House, sponsored by Rep. Emily McAsey, to extend Chicago's ban statewide. However, opposition from manufacturers thwarted the efforts in the Senate. Progress continues regardless with retailers such as IKEA and Target stopping the sale of crib bumpers.

### **FURNITURE SAFETY**

KID partners with **Shane's Foundation** to reach parents with information on keeping their children safe from falling dressers, TV's and other furniture. We helped CPSC develop and promote their **Anchor It!** campaign urging the use of anchoring straps. For longterm solutions, we participate in ASTM International standard setting process to encourage the development of furniture that is less likely to tip.

# AND MORE...

There were other emerging issues this year that drew our attention. KID joined an ASTM standards group looking at laundry packets after thousands of injuries occurred when children handled or bit into these toxic little packages. Similarly, KID supports legislation introduced in Congress to protect children from liquid nicotine now available widely with the advent of e-cigarettes.

# **TEST [TEACH EARLY SAFETY TRAINING]**

KID's TEST program is unique – bringing the principles of design safety to undergraduate engineering students through real world hazard scenarios and design projects. How does the project promote safer products?

### LET'S FOLLOW ONE TEAM:

A team of four students is given this scenario: Everyday 40 children under the age of 18 are sent to the emergency room when a piece of furniture like a dresser or bookcase tips over onto them. The goal of this project is prevent furniture tip overs through product design and testing. Can you design a piece of furniture for a child's room that reduces the risk of tip-over?

The team researched injury data and the current market. They bought a dresser from IKEA – a common choice for a child's room – and redesigned it to have a trapezoid shape – changing the center of gravity and greatly reducing the risk of tip-over.

The students learned lessons on design safety, end users, foreseeable use, standards and pre-market testing.

When these students graduate and work in industry, they will bring extra insights to design that will make future products safer. Each year at

Northwestern University alone, KID works with almost 100 students on various projects. We also work with teams at University of Michigan, Harvey Mudd College and others.

Stepping back for a wider view, industry, CPSC and those in the product safety field also get viable solutions to seemingly intractable problems. CPSC requested this prototype and used it to highlight one approach to reducing tip-over injuries. Three other teams came up with equally viable solutions. And this is just one set of projects – KID also looked at stroller and high chair safety along with microwave scalds and ingestion of laundry packets. KID shares project prototypes with standard setting organizations, manufacturers and CPSC to help in developing safer products in the future.
