

Stroller Safety Tips

Follow the manufacturer's instructions on assemble, use and care of the stroller. Fill out and return the product registration card, so the manufacturer can contact you in the event of a recall.

Make sure that latches are fully locked before use. Children have been injured when strollers which appear to be fully set up collapse, after hitting a bump.

Don't overload the stroller. This may cause it to collapse or tip.

Always restrain child with straps as recommended by manufacturer's instructions. When using a carriage or stroller in the fully reclined position, close the leg openings so that the child cannot slip through.

Never leave a child unattended in a stroller. It is not a safe environment for sleeping or playing.

When folding or unfolding a stroller, keep children away so that their fingers do not get pinched.

Stroller Safety

Although strollers allow freedom of movement for parents and caregivers to enjoy a variety of activities with their children, they must be used with caution.



Strollers, like many juvenile products, are not required to meet mandatory safety standards before they are put on the market.

According to the U.S. Consumer Product Safety Commission (CPSC), over 11,000 children are rushed to the emergency room each year due to injuries that involve strollers.

This brochure will equip parents and caregivers with vital information to keep children safe.
