Since our founding in 1998, KID has been working to improve the safety of children's products, including sleep environments. KID was founded after the death of Danny Keysar in a recalled portable crib. It turned out that crib had been recalled five years earlier. To this day, more than 10 years after Danny's death, these recalled cribs are still found in use and for sale in the second hand market. For each of these recent recalls of a million cribs, past recalls tell us that over 850,000 of them will remain unaccounted for. That is unacceptable.
