Introduction

Parents believe that when they buy a new product from a store or brand they recognize, it will be safe for their child. This annual list of recalls compiled by Kids In Danger belies that sense of security. Necklaces that poison their wearer, travel swings that dump their infant occupants on their faces and pacifiers that fall apart in a baby's mouth were some of the products recalled this year. Although this list might sound far-fetched, it is all too factual. These are just a few examples of the dangerous, poorly designed products that are being sold and used in our homes and childcare facilities.

Without stringent regulation by CPSC, dangerous children's products will continue to be sold and recalls will continue to go unnoticed, compromising our children's safety.

The U.S. Consumer Product Safety Commission

Congress created the U.S. Consumer Product Safety Commission (CPSC) in 1972 under the Consumer Product Safety Act (CPSA) and CPSC began operating in 1973. In the Consumer Product Safety Act, Congress directed the CPSC to protect the public "against unreasonable risks of injuries associated with consumer products."

The CPSC has jurisdiction over more than 15,000 kinds of consumer products, and is charged with protecting consumers from products that pose fire, electrical, chemical, or mechanical hazards or can injure children. Hal Stratton is the current CPSC chair.

Methodology

KID obtained all recall information for this report from monthly lists of the CPSC 2004 press releases, issued jointly by product manufacturers and the CPSC. The press release outlines the incidents, failures, and injuries caused by the product prior to the date of recall. All numbers, facts, and figures contained in KID's annual report were taken from these press releases. Only children's products under the jurisdiction of the CPSC were considered. This excludes car seats and booster seats that are regulated by the National Highway Traffic Safety Administration. However, CPSC does have oversight over car seats that might double as an infant carrier, for their use outside of cars.

Definitions

A children's product is defined as any product designed or intended for the care of, or use by, children. Products that pose a potential danger to children that are not intended for their use are not counted as children's products, such as cigarette lighters with faulty child resistance locks.

Children's products were further categorized by the type of product: clothing, nursery, sports and playground equipment, and toys. The product name, manufacturer, number of units recalled, type of hazard, and incidents of failure, injury, and death were recorded for children's products recalled in 2004. (Appendix A).

Recalls up from 2003, but still down from previous levels

The number of children’s product recalls rose 32% to 87 between 2003 and 2004, but is still down 26% from 2001. In 2000 and 2001, children’s product recalls comprised over 50% of the total number of recalls; however, 2003 and 2004 have seen that number drop by 20 points to 31%. Due primarily to the record recall of lead-laced jewelry, the number of units of children’s product recalls were 25 times as high as in 2003 and 4 times as high as in 2000, the previous high this decade.

Toys continue to lead children’s product recalls

Children’s product recalls break down into five categories: toys, clothing, furniture, sports and playground equipment, and nursery products. Toys represent almost half of children’s product recalls in 2004.

Several recalls involve well over one million units

In 2004 two children's product recalls accounted for one million units or more per recall. The largest was A&A Global, Brand Imports, Cardinal Distribution, Brecker and Co's recall of **150 million** toy necklaces that were sold in vending machines for about 50 cents. The metal in the jewelry contains high levels of lead, posing a risk of poisoning to young children. The second largest recall was of **1 million** Brand Imports LLC children's toy rings. These products were also sold in vending machines for \$0.25 to \$0.75 each. Like the other products, the LLC's rings contained dangerously high levels of lead, and are hazardous if swallowed or sucked on due to lead poisoning. The lead in these products became known when a child ingested one and became ill with acute lead poisoning – a rare occurrence.

In addition to lead hazards, other large recalls involved choking, lacerations, burns and impact injuries.

Numerous companies with multiple recalls

Eight companies recalled more than one product in 2004. Meijer Distribution led the industry with three recalls totaling 91,055 units. Their largest recall was of the Fall Creek Jacket. The zipper can come off and pose a choking hazard to children.

Brand Imports LCC recalled two products, toy necklaces and toy rings, both due to the risk of lead poisoning. They were also at the top of our list for most units recalled.

Six other manufacturers issued two recalls each in 2004; Graco Children's Products, Hasbro Inc, Kmart Corp, Regal Lager Inc, Swing N' Slide, and Target Group.

Bodily Injury is the leading hazard in 2004 recalled children's products

The most common hazard in the products recalled in 2004 was risk of bodily injury. Bodily injury includes falling, laceration, and impact injuries. Out of 90 children's product recalls, 39 of them were due to risk of bodily injury. Out of the 39, 15 were sports or playground equipment.

Cosco manufactured 300,000 faulty Rock 'N Roll Baby Stroller units, recalled for being a fall hazard. The Travel Lite Swing by Graco Children's Products Inc., recalled for the risk of impact and falling injuries, led to 128 reported injuries.

Reported failures before recall

Graco's Travel Lite Swing, recalled in 2004, had 128 failure incidents before being recalled, as shown in Table 6 below. Graco was recently fined for failure to report possible hazards with many of their products. According to the recall notice sent out by the CPSC, the handle on this swing can come out of place and hit the child on the head. In addition, the seat belt fails to restrict the child's movement to prevent them from falling forward partially out of the swing.

The Baby Bjorn Baby Carrier Active, by Regal Lager Co., received 93 failure reports before being recalled. The back support buckle on the carrier can detach from the shoulder straps which poses a falling risk to infants riding the inside.

Injuries and Deaths from Recalled Products in 2004

One product, a ride-on toy truck from Tek Nek Toys, led to a death when a toddler aspirated the loose screw. There were six other reports from that company of the screw coming out. It is not publicly known if the reports of failure without death preceded the death.

Graco led the list of recalls with the most reported injuries. With the recall of the Travel-Lite Swing, Graco did not differentiate between incidents and injuries, but it is clear that most of the reports involved injuries – up to 128. In addition, another of their products, a toy attachment for strollers and high chairs, caused five injuries before recall.

Recommendations

Kids In Danger has been releasing reports on children's product recalls since 2002. Each year, the story is the same: repeat offenders, clear violations of federal regulations on choking hazards and other products, injuries and deaths from products that came to market without adequate testing and stayed on the market for way too long after their hazards were known to the company. Moreover, as in the past, this year there were millions of products in homes, schools, and childcare that were hazardous and millions of them will never be recovered. It is time for action.

- The current fine cap for violations of manufacturer's self-reporting requirements must be lifted. The threat of a large fine must be available to the CPSC to encourage compliance.
- Given companies' lack of compliance with self-reporting requirements, CPSC must reevaluate their reliance on that information for safety actions. CPSC needs additional staff and funds to investigate potential dangers, rather than waiting for companies to report them.
- Recalled products are next to impossible to retrieve. Congress should allow CPSC to set mandatory standards and require certification of testing to those standards prior to sale of infant and toddler products. Children cannot be the guinea pigs for unsafe products.
- Children's products should come with product registration cards for the sole purpose of notifying consumers when a product has a defect or is recalled.
- States should enact legislation to ban the sale of recalled products or their use in childcare facilities. Only seven states, including Illinois, now have a Children's Product Safety Act.
- Information on injuries and incidents reported with products should be available to the public. Even if CPSC decides not to issue a recall, as in the case with yo-yo balls and the Graco Pack n' Play with changing table attachments, parents could decide for themselves if they wanted to take the risk.

Actions for Parents and Caregivers

While this report paints a bleak picture of the safety of children's products, there are steps parents can take to keep their children safe.

- **Learn about the problem:** Visit www.KidsInDanger.org for more information on children's product safety.
- **Check your products for recalls:** Take an inventory of the products used with your children – both at your home, at childcare and elsewhere – and check it against the list of recalls at www.cpsc.gov. Check car seats at www.nhtsa.gov. Repeat the check every time you accept a donated item or pass something along to a friend or relative.
- **Keep up on recalls:** Sign up for email notice of recalls at www.cpsc.gov and for monthly safety updates at www.KidsInDanger.org.

- **Report problems:** Report any injuries or problems with products to both the manufacturer and CPSC (www.cpsc.gov). CPSC cannot take action if they do not know of the problem.
- **Urge your state to take steps to protect children:** Your state can adopt the Children's Product Safety Act that bans the sale or lease of recalled products or their use in childcare. Find out more at www.KidsInDanger.org advocacy pages.
- **Urge Congress to provide more oversight for children's safety:** Congress plays a pivotal role in assuring the CPSC has the tools and the will to do their job to protect our children. Tell your congressional representative to take an active role in ensuring safe products by supporting the Infant and Toddler Durable Product Safety Act, soon to be introduced by Representative Schakowsky and by requiring CPSC to report to Congress on recall effectiveness.
