Executive Summary

Since 2002, Kids In Danger (KID) has released an annual report detailing children's product recalls throughout the previous year. This year's report examines children's product recalls in 2010 and looks at other changes in product regulations that will have an impact on safety.

Findings of the report include:

- Forty-five percent (160) of the products recalled by CPSC were children's products.
- Nursery products were the most-recalled category with 29% of children's recalls, followed closely by clothing (mostly for drawstrings) at 28%.
- There were 11 recalls of 1 million or more units, totaling over 37 million units of recalled children's products. The largest single recall was of 12 million McDonald's Shrek glasses tainted with cadmium, a dangerous heavy metal.
- Nursery products had the most injuries prior to recall (108). The individual product with the most injuries prior to recall was the Step2 Push Buggy with 28.
- There were 18 deaths reported prior to recall in these products. Sixteen of the deaths occurred in nursery products, while two involved a toy gun.
- Four of the five products with more than 100 reported incidents before recall were nursery products, including a stroller, a gate and cribs. The product with the most incidents reported before recall was a trampoline, with 247 reported incidents.
- Twenty-nine sleep environment products were recalled, including drop-side cribs, beds, a sleeping device and mattresses.
- CPSC imposed a total of \$2.7 million in fines for companies who violated safety regulations, mostly for excessive lead in toys and drawstrings in children's clothing.

Other product safety actions this year:

- CPSC and FDA warned consumers about the dangers of sleep positioners and urged against their use. Most retailers immediately stopped selling the product.
- CPSC issued warnings on the use of baby slings and gave directions for their safe use.
- A new mandatory standard for cribs and portable cribs was developed and adopted. It goes into effect June 28, 2011.
- The CPSC public database was developed and goes into effect on Friday, March 11.
- Most nursery products are now covered by a requirement to provide a product registration card and website to assist in alerting consumers in the event of a recall.

KID recommends:

- Congress should require annual reports on recalls and their effectiveness.
- Congress should protect the provisions of CPSIA, giving CPSC the flexibility necessary to fully implement the law.
- CPSC should consider action against crib bumper pads, involved in at least 2 deaths in 2010 and 30 in the past decade.
- Consumers should check their products against the recall lists and register new juvenile products.

Introduction

Kids In Danger's (KID) annual children's product hazard reports examine data and trends in children's products that have been recalled by the U.S. Consumer Product Safety Commission (CPSC) each year. This year's report examines children's product recalls in 2010 and looks at other changes in product safety regulations that will have an impact on safety. KID has been doing this since reporting on 2001 recalls in early 2002. While recalls numbers have risen and fallen during that time, this year CPSC has taken other actions which will have a direct impact on future safety of children.

Congress created the U.S. Consumer Product Safety Commission (CPSC) in 1972 under the Consumer Product Safety Act (CPSA). In the CPSA, Congress directed CPSC to protect the public "against unreasonable risks of injuries associated with consumer products." CPSC has jurisdiction over more than 15,000 kinds of consumer products, and is charged with protecting consumers from products that pose fire, electrical, chemical, or mechanical hazards or can injure children. In 2008, after record numbers of recalls of lead-tainted toys, hazardous magnetic toys and deadly cribs, Congress passed the Consumer Product Safety Improvement Act (CPSIA). While the legislation had a built in implementation calendar that extended several years into the future, additional difficulties in implementation have led to stays of enforcement on some requirements, such as third party testing for lead. But with new powers, new resources and leadership invested in safety, CPSC made substantive improvements to product safety this year.

2010: Recalls of children's products slightly up from 2009

In 2010, there were 355 recalls issued by the CPSC, of which 160 or 45% were children's products. This is a slight uptick over 2009, but still far below the record highs in 2007 of 448 recalls and 231 children's product recalls. The slight increase can be partially attributed to the numerous recalls to remove failure-prone drop-side cribs from use along with continued efforts to get manufacturers to remove drawstrings from children's clothing. Recalls in 2010 totaled over 44 million individual units.

Nursery products continue to lead children’s product recalls, followed by clothing and toys. Nursery products and clothing surpassed toys in 2010 again as the leading recalled product types. Toys had been the most recalled product category each year from 2001-2008. Nursery products – cribs, strollers, high chairs and pacifiers for example – accounted for 29% of children’s product recalls and 13% of all recalls. Most were recalled due to entrapment, strangulation and bodily injury (fall). Clothing represented 28% of children’s product recalls and posed strangulation and choking hazards due to drawstrings and small parts. Toy recalls have declined from 41% to 21% of recalls from 2008 to 2010. The majority of the toys were recalled for choking hazards.

Recalls increase in size

In 2010, there were eleven recalls of 1 million or more units. Those recalls alone accounted for 76% of the recalled units. At the top of the list was a 12-million-unit recall for McDonald’s Corporation whose Shrek drinking glasses were found to contain cadmium. Other hazards in the largest-unit recalls include entrapment, bodily injury (fall and laceration), positional asphyxia and choking.

Several manufacturers had multiple product recalls

Fourteen manufacturers reported more than one recall and four manufacturers had three or more. Fisher Price had five different product recalls. Williams Sonoma brands (Pottery Barn Kids, Williams-Sonoma and PBTeen) also had five combined recalls. Graco and Step2 each had three separate recalls. The recalled products of these five companies created entrapment, fall, lacerations, burns and choking hazards to children.

Made in China, but also in the United States

Children's products recalled in 2010 originated in 25 different countries, but the majority once again came from China. Chinese factories made 115 recalled products, 72% of recalls. The next biggest group of recalls were from the US (18) – 11% of the recalled products were made right here. Vietnam (15), Mexico (8), Indonesia and Taiwan (6 each) round out the top spots.

What are the hazards posed by these recalled products?

Just over 20% of the recalled products posed a strangulation hazard. Most were clothing with drawstrings, but a few were toys or nursery products with straps or cords. Choking, poisoning and entrapment hazards each were involved in 18% of the recalls. Poisoning included lead tainted products (75%), products with cadmium (21%), a relatively new hazard or one product -- a cabinet safety latch that failed -- that could lead to access to poisons. Forty-seven percent of toy recalls involved choking hazards, mostly for small parts that break off easily. Eighty-two percent of the entrapment hazards were in sleeping environments – cribs, beds, or portable cribs – the very places children are left unattended.

What leads to a recall?

Recalls are prompted sometimes from a consumer complaint or injury; sometimes from other reports of hazards and sometimes from the manufacturer’s own review of their product. Here are some of the indicators for recalls.

Incidents – reports of harm or possible harm from a product

In 2010 there were 1,587 incidents reported prior to recall for the 160 children’s product recalls. It seems CPSC is acting a little quicker than last year when there were over 4,000 incidents, including two recalls with more than 1,300 reports each of a hazard and six more with more than 100 reports. This year, there were four recalls with more than 100 reports. There were 23 injuries with those products and no deaths. Dorel Asia had 67 reports on their drop-side crib, including 10 injuries and a death before it was recalled.

Injuries: consumers hurt before a product is removed from the marketplace

Injuries from recalled children's products totaled 163 before these hazardous products were recalled. Twenty-four percent of children's product recalls involved injuries prior to recall, up from 17% last year. More than half (51%) of the nursery products were recalled only after a child had already been injured, nine only after a death. Outdoor & sports products involved an injury 45% of the time and 40% of furniture, recalls involved injury prior to recall.

A push buggy by Step2 had the most injuries prior to recall – 28. Other products with more than 10 injuries were a gate from Evenflo (11) and the Dorel Asia drop-side crib (10 with one death).

Deaths – a child dies before the product can be recalled

There were eighteen deaths in children's products recall in 2010, double 2009's number. These deaths occurred in ten different products, mostly nursery products, but one toy. Four products had more than one death before recall.

Recalled products that violate a federal standard or requirement

Many of the recalls were for products that violate current mandatory standards, in particular, lead paint or content, drawstrings in children's clothing or small parts in products for children under three. Fifty-seven percent of the recalled products violated these standards. Most had no incidents or injuries. This is one hazard that can be reduced through mandatory third party testing.

Sleep environment products remain a serious hazard

In 2010, CPSC recalled 25 sleep environment products involved in 72 injuries and 9 deaths. Half of the 18 deaths in children's products occurred in sleep environment products.

Companies pay penalties in 2010

The CPSC is increasingly holding companies accountable for allowing unsafe products to reach store shelves and the homes of millions of children. In 2010, 5 companies paid civil penalties for children's products hazards or reporting issues, adding up to approximately \$2,665,000. Daiso

received the largest penalty with a \$2.05 million settlement for violating federal laws and regulations including lead content, lead paint, phthalates, small parts and lack of warning labels. Other companies failed to report unsafe drawstrings on children’s clothing and violated the lead paint ban for children’s toys. Of the fines, three companies paid the full amount – Pro Pac Distributing, Jo-Ann Stores and Daiso and two paid a partial amount – Schylling Associates and Winter Bee. Both had already agreed to pay only a portion of the original fine, but then failed to pay even that agreed upon amount.

In March of 2010, CPSC fined Daiso Holding USA Inc. for \$2.05 million and issued an unprecedented “consent decree” in response to violations that included distributing and selling toys with illegal levels of lead and phthalates, small parts on toys for young children, and products without warning labels. The consent decree prohibits Daiso from importing or selling any products until they implement a comprehensive product safety program and all of its toys meet federal safety standards. CPSC’s actions display increased assertiveness in enforcing product safety laws and send a clear message to manufacturers that safety must come first.

Product Safety Activity in 2010

KID’s past reports have focused exclusively on recalls in the previous year. But this year, CPSC took so many other actions that have an impact on children’s product safety that it would be an incomplete picture of safety to not include some of them.

March 12, 2010: CPSC issues a general warning on the use of **baby slings** and gave directions for parents for their safe use. The warning reported 14 deaths over the past 20 years. Less than two weeks later, they announced the **recall of the Infantino** bag style SlingRider sling. That sling was responsible for at least three of the deaths. However, bag slings almost identical to the SlingRider by other manufacturers have never been recalled. While slings have been used safely for generations, parents should be aware of the position of their baby within the sling and always be able to see and kiss the baby’s face – meaning it is uncovered and up towards the face of the carrier. There is currently work underway on the voluntary standards committee to develop a standard for these products, requested by some of the manufacturers.

June 4, 2010: Baby bath seats become the first product with a new mandatory standard promulgated under the Danny Keysar Child Product Safety Notification Act contained in the CPSIA. CPSC worked with the voluntary standard setting body, ASTM International, to draft a tough new standard for this product associated with as many as 10 deaths a year. Walkers followed shortly after on **June 21, 2010**. KID originally worked with Congresswoman Schakowsky in 2001 to draft the requirements for infant and toddler durable products standards and testing that were eventually included in the 2008 CPSIA.

Starting in **June 2010**, most nursery products are now covered by a requirement to provide a product registration card and website to assist in alerting consumers in the event of a recall. CPSC Chairman Inez Tenenbaum joined Kids In Danger, Illinois Attorney General Lisa Madigan and other advocates in Chicago to announce the new program, named after Danny Keysar in the CPSIA. In next year's report KID will attempt to have beginning analysis of the success of this program.

September 29, 2010: CPSC and FDA warn consumers about the dangers of sleep positioners and urge against their use. Most retailers immediately stopped selling the product and most manufacturers no longer make these items. KID has been working to ban sleep positioners since 2002 when two-month-old Andy Sage was suffocated by one. While new sleep positioners are off store shelves, they remain in homes and the secondary market and many parents have yet to hear the warning.

December 28, 2010: A new mandatory standard for cribs and portable cribs was developed and published. In addition to banning the dangerous drop-side design involved in dozens of deaths, it also puts in place rigorous performance standards and testing to assure new cribs are durable and able to stand up to real world use. All cribs sold after June 28, 2011 will have to meet this new standard (including used cribs) and all child care facilities and public accommodations such as hotels will have to provide only cribs meeting this standard by December 28, 2012.

The CPSC public database was developed and goes into effect on **Friday, March 11, 2011**. This unprecedented (at least at CPSC, many other agencies have provided this information for years) access to injury reports from consumers will not only help individual consumers making purchasing decisions, but will help indentify injury trends and emerging hazards.

Conclusion

This report highlights both concerns and successes regarding children's product safety in 2010. The high number of children's products recalled in 2010, especially those that caused injuries and deaths, remains a serious concern. The continued recalls of strollers and high chairs indicate that perhaps those products should get the same scrutiny CPSC has successfully turned on cribs. CPSC's increased efforts and enforcement of product safety laws signal that products will be safer in the future. KID does have recommendations for both CPSC and Congress.

- CPSC should launch the public database this week as planned. Because the database starts blank, it will be sometime until its full potential for spotting injury trends and emerging hazards will be realized. But we believe consumers will be well served by this public information.

- To improve recall effectiveness, Congress should call for annual reports on the year's recalls and their effectiveness. Only under public scrutiny will companies put more effort into removing recalled items from homes and childcare facilities.
- CPSC should also require more from companies in the event of a recall. In addition to the mandatory recall requirements and product registration cards required by CPSIA, CPSC should require more aggressive outreach after a recall and require a replacement product or refund when possible, increasing the likelihood of retrieval.
- Given the number of nursery product recalls and the number of deaths and injuries involved, CPSC should continue with the mandatory standard rule making and continue to develop much tougher standards for products with poor track records such as high chairs and strollers.

Action for Parents and Caregivers

KID urges every parent and caregiver to take the following **three steps to protect children in their care**.

1) Be aware of the problem: Visit www.KidsInDanger.org for more information on children's product safety and to sign up for free email alerts to stay up-to-date on recalled products. Consumers can also sign up at www.cpsc.gov to receive notice of recalls by email.

2) Always check products: Take an inventory of the products used with children—at home, at childcare, and elsewhere—and check it against the list of recalls at www.cpsc.gov. Check for safety information on car seats at the National Highway Traffic Safety Administration (NHTSA), www.nhtsa.gov. Repeat the check every time a child receives a new product, gift, or hand-me-down. Report any injuries or problems with products to both the manufacturer and CPSC.

3) Spread the word: After learning of a recall, share the news with friends and family and urge them to pass it along. Always fill out product registration cards so manufacturers can send recall information. Under CPSIA, product registration cards and online registration are required for durable infant and toddler products.

Also, take special precautions with sleep environments. Visit KID's product hazard pages on cribs, portable cribs, bassinets, and soft bedding to learn how to provide a safe place for baby to sleep. Report any product that breaks or appears dangerous so that CPSC is aware of the problem.

Methodology

Kids In Danger obtained all recall information for this report from monthly lists of press releases generated by the CPSC and issued jointly by product manufacturers and the CPSC. Press releases outline the incidents, failures, and injuries caused by the product prior to the date of recall. All numbers, facts, and figures contained in this report originated in these press releases. Manufacturers have editorial power over the form of the recall release – so it is not certain that these are all the known incidents, just that these were reported. Only children's products under the jurisdiction of the CPSC were considered. This excludes car seats and booster seats

regulated by NHTSA. However, CPSC does have oversight of car seats that also function as infant carriers.

Definitions

A children's product is defined as any product designed or intended for the care of or use by children. Products that pose potential dangers to children but that are not intended for their use, such as cigarette lighters with faulty child resistance locks and window blinds, are not counted as children's products. Children's products were further categorized for this report by the type of product (clothing, furniture, nursery products, sports and outdoor, jewelry, art and school supplies, books, miscellaneous, and toys). The product name, manufacturer, date of recall, number of units recalled, type of hazard posed, and number of incidents and injuries were also recorded for children's products recalled in 2010 (Appendix A).
