# **KID'S ANNUAL RECALL REPORT**

KID was joined by US Congresswoman Jan Schakowsky, Illinois Attorney General Lisa Madigan, Sessy Nyman of Illinois Action for Children and Maggie Galka of Illinois PIRG in releasing this year's report on children's product recalls. KID will use the findings to drive policy and actions to improve recall effectiveness and product safety.

## A DECADE OF DATA: AN IN-DEPTH LOOK AT 2014 AND A 10-YEAR RETROSPECTIVE ON

CHILDREN'S PRODUCT RECALLS

SINCE 2002 **Kids In Danger (KID)** has released an annual report detailing children's product recalls throughout the previous year. This year we also looked back over 10 years of children's product recall information and effectiveness.

#### TYPES OF CHILDREN'S PRODUCTS RECALLED MOST IN

# NUMBERS THAT MATTER 85% DECREASE

IN THE NUMBER OF INJURIES REPORTED FROM 2013. THERE WERE A TOTAL OF 338 INCIDENTS, 29 INJURIES & 3 DEATHS REPORTED BEFORE THE RECALL WAS ISSUED.

## NUMBERS THAT MATTER RECALL EFFECTIVENESS 2013 80% OF 2013 RECALLED

PRODUCTS WERE IN THE HANDS OF CONSUMERS AT THE TIME OF RECALL LESS THAN 4% OF THOSE RECALLED PRODUCTS HAVE BEEN SUCCESSFULLY FIXED OR DESTROYED.

19,581 Incidents 2,462 Injuries 57 Deaths Since *Danny's Law* was implemented in **2008** there has been a steady decrease in the number of children's product recalls.



**KIDS IN DANGER (KID)** is a nonprofit organization dedicated to protecting children by improving children's product safety. KID was founded in 1998 by Linda Ginzel and Boaz Keysar, the parents of sixteen-month-old Danny Keysar who died in his Chicago childcare home when a portable crib collapsed around his neck.

KID's mission is to **PROMOTE** the development of safer children's products, **ADVOCATE** for children, and **EDUCATE** the public, especially parents and caregivers, about dangerous children's products.

## **STUDENTS LEARN FROM REAL-LIFE HAZARD ANALYSIS & DESIGN SOLUTIONS**

KID has been working with engineering students at Northwestern University for almost a decade. Our **TEST program** is focused on integrating design safety into undergraduate engineering education. Through the Segal Design Institute's freshman program, **Design Thinking and Communication**, students are presented with a design challenge and teams of four develop prototypes to address the issue and present their findings at a **Design Expo**.

This term, KID worked with two sections – each with four teams. One set of teams looked at the *hazard of tip-overs* – furniture, televisions, or appliances falling on young children. After learning more about the issue, talking to users, and sketching possible designs, the groups focused on making furniture for a child's room that would be tip-resistant. Their professor, **Walter Herbst**, further defined the challenge by asking them to imagine they worked for Ikea. The four teams took existing Ikea furniture and designed anti-tip solutions. These included a trapezoid shaped dresser with a wider base, one with guards that pull out with the top drawer, a dresser with a wider base incorporating a bench to change the center of gravity and a turntable-type shelving unit to replace a dresser. All were stable without the need for wall attachments.

The second group was given the task industry and regulators are working on right now – how to protect children from the dangers posed by individual laundry packets. Over **17,000 calls** have come into Poison Centers about children being exposed and facing injury from laundry packets' highly concentrated content. There has been at least one death. The teams came up with design solutions in three areas – making the container holding the packets child resistant, lessening children's access to individual packets when out of the container and warning labels. Solutions ranged from blister pack type coverings, balls or mesh that enclosed the packets and could be recycled, innovative child resistant closure on containers and highly visible warnings – such as on the seal of the packaging so parents had to handle it to get to the contents. The resulting prototypes and ideas will be shared with those working on standards and new designs.

## **NO BUMPERS!**

It is a unified message from doctors and groups working on children's health and safety: Bare is best when it comes to a crib – leave the bumpers and all other soft bedding out to keep baby safe. Major retailers such as Ikea and Target have removed padded crib bumpers from their store – and online – shelves. As we have reported, both Maryland and the City of Chicago ban the sale of crib bumpers. Now KID is working with a strong coalition to ban the sale statewide in Illinois. If **HB 3761** by Illinois Representative **Emily McAsey** would go into effect in January 2018. **Check our advocacy page on our website and Facebook and Twitter for updates**. Joining KID at the expo were **Shane's Foundation founder Lisa Siefert** and **US Consumer Product Safety Commissioner Joe Mohorovic**. Lisa's son Shane was killed by his dresser exactly four years prior to this expo. Her work has raised awareness of the issue. Commissioner Mohorovic has cited tip-overs as one of his core issues at the commission, in part due to the latent nature of the hazard—many families have no idea of the dangers posed by falling furniture and televisions.

This was a fabulous project. The four very different designs were innovative. These teams really went outside conventional thinking. I hope to see designs like these picked up by manufacturers. It would be wonderful for families to take home furniture that would not require an anti-tip device to be installed and just be inherently safe.

## MEET MARY BETH AND SEE HOW KID HAS HELPED HER KEEP CHILDREN SAFE

Mary is nurse and has spent the last 10 years working in an Early Head Start program in rural Southern Illinois. The program is home based and involves visiting local families with young children. Says Mary, "I love home visiting and feel like it gives us a unique opportunity to share important topics like children's product safety in the home where families are most comfortable. In the home, we can actually look and see where the child is sleeping and do other safety checks." We asked her a few questions about KID's impact on her work.

How did you learn about KID? I learned about KID at a session I attended at the Illinois Head Start Association Conference in Springfield presented by KID Program Director Laura Nikolovska.

As a result of KID's safety training, what actions did you take in your facility? I learned so much at the KID's safety training that we are going to implement in our home visiting *Early Head Start* program. First, we are going to conduct a product inventory to check for any safety recalls at our two sites. Secondly- I will use information to do trainings with our other Early Head Start staff. Finally, I will share all the great resources Laura provided not only with staff but also with the parents we serve and even our community partners.

What surprised you during the training? Probably the biggest surprise was information on tip-over deaths. This was a light bulb moment for me because I realized that is not something we are consistently covering at home visits. When we visit these homes in the future we have the perfect opportunity to share information on this risk.

How does KID continue to be a resource to you? Since the training (last week), I have already emailed Laura a couple times asking questions. I have also ordered safety materials for display and distribution in my facility. Monthly I will receive KID's email alerts with safety news and product recalls.

**KID's work matters because...** When you are doing home visiting in programs like **Early Head Start**, we have the perfect opportunity to provide safety training with our families and KID's work helps us provide the most up to date information and resources that are available.

Stories like Mary Beth's are repeated over and over each year. In less than three months in 2015, KID has reached over 300 providers personally which is magnified exponentially when they share with the families they serve.
